How to Register Your Chickens with the State of Wisconsin

Before applying for your Village of Johnson Creek chicken permit, you must first register your premises with the **Wisconsin Department of Agriculture**, **Trade and Consumer Protection (DATCP)**. This registration is required for all chicken owners in Wisconsin.

Follow these steps to register your premises:

1. Visit the Wisconsin DATCP Registration Page:

- 2. Complete the Registration Form Online:
 - On the DATCP page, click the link for the Livestock Premises Registration Application.
 - o Fill out the required fields, including your contact information and farm address.
 - o Provide details about your facility, including the location of your chickens.
 - Submit the completed form online.
- 3. If You Prefer to Mail a Printed Copy:
 - You can go to the above link to **download the application form and print**.
- 4. **Mail** the completed form to:

- 5. Receive Your Registration Card:
 - After submitting your registration, you will receive a Premises Registration Number and a Livestock Premises Registration Card from DATCP.

- 6. Bring Your Registration Card to Village Hall:
 - O You will need to submit your **Premises Registration Card** when renewing or applying for your Village of Johnson Creek chicken permit.
