## How to Register Your Chickens with the State of Wisconsin

Before applying for your Village of Johnson Creek chicken permit, you must first register your premises with the **Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP)**. This registration is required for all chicken owners in Wisconsin.

**Follow these steps to register your premises:**

1. **Visit the Wisconsin DATCP Registration Page:**  
Go to: [datcp.wi.gov/PremisesRegistration](http://datcp.wi.gov/PremisesRegistration)
2. **Complete the Registration Form Online:**
  - On the DATCP page, click the link for the **Livestock Premises Registration Application**.
  - Fill out the required fields, including your contact information and farm address.
  - Provide details about your facility, including the location of your chickens.
  - Submit the completed form online.
3. **If You Prefer to Mail a Printed Copy:**
  - You can go to the above link to **download the application form and print**.
4. **Mail the completed form to:**

5. **Receive Your Registration Card:**
  - After submitting your registration, you will receive a **Premises Registration Number** and a **Livestock Premises Registration Card** from DATCP.
  - If you submit the form by mail, your registration card will be sent to you.
6. **Bring Your Registration Card to Village Hall:**
  - You will need to submit your **Premises Registration Card** when renewing or applying for your Village of Johnson Creek chicken permit.
